This is a full restaurant coffee house.

Under new management for about one year ago.

No employees, owner operated.

Cafe offers meals, sandwiches and non-alcoholic beverages and desserts.

Special amenity is ""hookah service"" inside the restaurant.

This is not a tobacco smoking operation.

The kitchen is in back of building separating dining area from neighbors in the rear.

Operating hours are 5:00pm to 2:00 am.

The busiest hours are from 8:00 pm till about 12:00 am.

Just started entertainment three months ago.

Monday evening comedy performers. Wednesday evening is Karaoke.

There is a big screen T.V. for viewing sports events.

No private parking, offer valet parking.

Requesting a beer and wine license.

Licensed to operate as coffee shop.

""Hookah pipes"" are cleaned daily as required by the law.

Disposable tips are used for the ""Hookah pipes"".

Regular customers have requested beer and wine.

We are looking to increase the services and the income from this Cafe'.

Will make structural adjustment to comply with ADA requirements.

COMMITTEE COMMENTS:

Are the hours that you operating consistent with other restaurants that are serving beer and wine in the immediate area?

We know there have been problems in this area with other operators. We will need to ask you back next month to give us time to notify the neighbors that you are applying for a beer and wine license, and extended hours.

PUBLIC COMMENTS:

In regards to the valet service, do you pay toward the liablility of that operation?

Are you useing the city streets to park your cars?

RESPONSE:

All the restaurants in the area have different hours for beer and wine service. We will be continuing with our present hours of operation.

We pay for this service, We are not sure about the liability insurance that they have to cover this operation.

This valet service is the same as the other restaurants in the area. They use the city streets and business lots that are not operating in the evening hours to park cars.

COMMITTEE ACTION:

We will ask you to return so that we can give public notice on this item. We will notify you the date of our February meeting as it will not be on the third Monday due to Presidents Day.
