Community comments: there were concerns about noise and parking in the neighborhood.

Committee Comments: concerned about reported COVID violations and that a mature tree was cut down in front of the restaurant. They were fined and had to replace tree.

Motion: To approve project for renewal of their CUB license. Will note to the Planner in charge about noise concerns of the community. Lisa Petrus moves to approve, Sue Steinberg seconds. Motion passes with 7 yes, 1 abstention, Rick Mayer (joined the meeting after discussion started).

7b.) 14016 Ventura Blvd. Taisho Restaurant where Café Bizou use to be located. This will be a casual Japanese Restaurant. Extensive improvements being made to the interior. Exterior changes require them to come before the PLUM committee. They will be removing the entry awning and make major changes to the front façade.
