Speakers in support of this request included: Ed Buck with Sherman Oaks California Golden Retriever Rescue, Melissa Maroff with Citizens Against Puppy Mills, and Patti Sugarman, Community Member

a. *ACTION ITEM* : From Executive Committee to allocate up to \$15,000 for "A Day in the Park" \$12,000 is already in the Budget the additional \$3,000 will be reallocated from Outreach Budget.

12 members in favor **Motion passed** Opposed: Kristin Ellington-Stiles Abstain: Max Calne and Neal Roden

b. ACTION ITEM : From Executive Committee to allocate up to \$9,963 for Street Services project. \$4,938 in Budget for Community Improvement- Other additional \$5,025 to be reallocated from Recreation and Parks to Community Improvement-Other. Unanimously Passed by Board.

ACTION ITEM: From Finance Committee motion to reallocate \$2,500 from budget line item for Beautification Projects to budget line item for Community Improvement- Other.
 Also to allocate \$2,500 (from the Community Improvement-Other) towards the purchase of one digital speed trailer to augment existing pedestrian signs near the intersection of Woodman and Riverside to be placed near and house at Notre Dame High School.
 Equipment had been approved by LA DOT and LAPD Valley Traffic Division and funds will be combined with funds from Notre Dame High School, Westfield Corporation, and CD2. (Need arises in part from recent tragic death of student struck by vehicle and need to monitor traffic activity and speeds in the area of the school).
