- 3. **Introductions** Committee members, elected officials and staff.
- 4. **Demo: Kids Safety -** Maria Turnhout, **KMA Blackbelt Champions**, will demonstrate the following:

Learning about boundaries is necessary for both children and adults. Maria teaches both self-defense and empowerment for children. The importance of the training is to reinforce the safety measures over and over. Recognizing a situation is better than just using self-defense techniques. Kids learn through role play games. They understand that "voice" is an important tool. Creating distance between a child and strangers. Learning to say "NO" and mean it. A practice where a child does all of the above and then informs the stranger that the child will get an adult. A child must be taught about "lures" used by predators; props such as animals or pretending they are injured or need assistance. Reminding a child they must never go off with a stranger no matter what the stranger is telling them.

Christy Adair says these training measures are like learning safety through fire drills.

Lisa Petrus, attendee, reminds us that if there are several children, the predator can use a divide and conquer technique.

Penny Gilbert says Thank You for the amazing presentation as it was instructive for adults as well as children.

- 5. Special Guest Speaker Officer Lois Westphal and Officer Tamralyn Shepphird, Los Angeles Animal Services, are Wildlife Specialist who discussed living around coyotes in Sherman Oaks.

LA Animal Services will respond to sick or orphaned wildlife through local Animal Services, reached by calling 311. It is illegal to feed wildlife. Coyotes will respond to humans, seeing how humans interact with their own pets and believe that humans will interact with them. If they approach clap loudly. This will scare them away.

Stacy Okonowsky, attendee, says she has noticed a significant increase in the coyote population--south of the Blvd and they roam in packs. She is fearful because Animal Services say we should learn to peacefully co-exist.

Officer Westphal says that she does notice more reporting of coyote sightings, but coyotes breed 2 times a year which explains the elevation of sightings and running in packs.

Stacy Okonowsky believes that it is just a matter of numbers increasing overall.

Officer Westphal says that in coming months the population and sightings should decrease. If a human makes a lot of noise, coyotes will learn to stay away from humans.

Christy Adair asks if there is an overpopulation problem and would the City step in and act.

Officer Westphal says that if the coyotes are removed it would create a negative impact in the environment and there would be consequences.

Barbara McDermott asked how high coyotes jump as there are various reports of their capability.

Officer Westphal says she has witnessed coyotes jump as high as 8 feet.

Christy Adair mentions that on Nextdoor people suggest leaving water out on very hot days for animals.

Officer Westphal says while it is not against the law to do so, wildlife will habituate to areas where food and water are easily accessible. They need to find their own resources and not become comfortable with humans.

7. Covid-19 Crisis Update – Jesse Smith

- The Los Angeles County Department of Public Health has confirmed 1,103 new cases of COVID. One month ago, on June 13, the 5-day average of cases was 201 and today the 5-day average is 1,095; this is an increase of more than 500% in one month
- The test positivity rate has increased nearly 700% from the 0.5% seen a month ago; today's test positivity rate is 3.4%. To date, Public Health has identified 1,259,772 positive cases of COVID across all areas of LA County and a total of 24,554 deaths.
- There are 375 people with COVID currently hospitalized and 23% of these people are in the ICU. Testing results are available for 7,126,000 individuals with 16% testing

positive. Sherman Oaks Vaccination rates-on shot-age 16+ 75.3% and 65+ 86.5%

8. Community Police Advisory Board Update ("CPAB") Update – Penny Gilbert

- Crime Overview--Valley
- Stolen Vehicles up 18% for the year
- Theft from motor vehicles up 34% for the year
- Assaults up 11.5%
- Residential burglaries not rising in Sherman Oaks
- LAPD's most important issues are finding health care and housing for the homeless. They are working with various City agencies.

9. Social Media Misinformation – Barbara McDermott

- Social Media posts continue to indicate that many residents still, falsely, believe that police won't be dispatched or respond unless a crime has actually occurred. As a blanket statement, this is not true, and believing this misinformation could prove dangerous. Police <u>do</u> respond to suspicious activity calls. There are some calls, depending on the circumstances, when police won't be dispatched, but the operator will tell you during your call whether or not the police will be dispatched. There are also some calls where, although officers won't be dispatched, the information will still be broadcast to area officers alerting them to the activity/person and allowing them to stop and make contact with that potential suspect if seen.
- If you're unsure whether to call the police about suspicious activity, *call*. Call while it's happening or as soon as possible when the suspect is likely still in the area. Don't take matters into your own hands call the police and be a good witness. You don't know if the person may have weapons on them, or what they might be willing to do if you confront them. You also don't know if they're wanted by the police or have a warrant out for their arrest.
- Your call to the police when you see suspicious activity (i.e. a prowler, trespass suspect, possible burglary/theft from motor vehicle suspect, etc.), could be the call that prevents a crime and/or ends in an arrest of a criminal.
- If you're unsure whether to call 911 or non-emergency dispatch 1-877-275-5273 (1-877-ASK-LAPD), call 911. The operators are trained to obtain the information needed to determine the response.
- <u>Important Note</u>: If you call to report something, and the situation then escalates or changes after speaking with the operator, <u>you need to call back to let them know</u>. Unless you call back, the police won't know that the situation has changed.
