4) Please describe the purpose and intent of the grant.

We would like to offer free group training to the adopters and fosters of Los Angeles Animal Services. We would like to, with your help, set a goal of 50 scholarships over 10 months. These ongoing classes would be offered every Saturday beginning in March 2025 and concluding in December 2025. We limit our Intro classes to 12 students, and we would offer up to 6 spots to the adopters and fosters, depending on the requests and needs.

 How will this grant be used to primarily support or serve a public purpose and benefit the public at-large. (Grants cannot be used as rewards or prizes for individuals)

By offering free dog obidience training, we give owners an alternative to surrendering or returning their adopted dogs back to the shelter.

Supporting fosters with free training, allows dogs to be in a home environment before getting adopted, easing the transition from shelter to home.

A study in the journal Animals found that short-term fostering can increase a dog's chances of adoption by 14 times.
